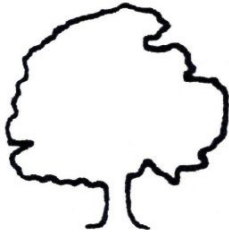

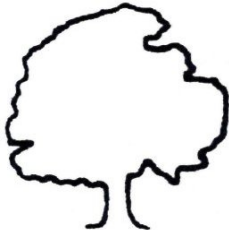

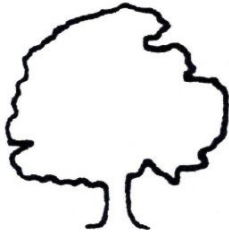

PLEASE NOTE:

- a) The Swimming Pool Area will be cleaned daily first thing in the morning, and will have a weekly deep clean.
- b) You will be responsible for cleaning surfaces used regularly during and at the end of the Swimming Session.
Hand Sanitizers are available on entry and exit of the Swimming Pool Area.
- c) Only Four Swimmers per swim session with NO spectators or groups.
- d) You must be one of the Four Swimmers using the Swimming Pool, and you **must** use your Key Fob on entry to the Centre.
- e) You are Not Permitted to Access any Areas designated as 'No Entry', 'Out of Bounds', 'Chained Off' or 'Unavailable'. You are Not Permitted to use the 'Emergency Door' in the Pool Area unless in the event of an Emergency.
- f) Access will be allowed 5 minutes before and after the specific time of Swim.
- g) All Persons waiting to Swim must adhere to social distancing outside of the front of building or remain in their vehicle.
- h) You will be expected to leave the building once your Swimming Session has completed and all the relevant cleaning has been completed.
- i) If you become ill during your Swimming Session with possible Covid-19 symptoms you must follow the correct procedure for Isolation and Government Track and Trace, and also notify the Centre Manager.

To comply with Government advice, the Board of Herne Farm Limited wish to ensure all users can be provided a safe and sanitized environment in which to return and access our facilities. A risk assessment will be available but may be subject to change at any time in line with Government and Village Hall Guidelines.
