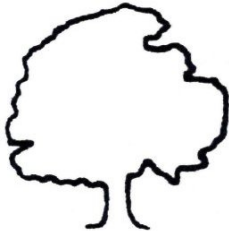
Herne Farm Squash Rules

Page 1 of 3

The following Squash Rules will apply to ALL Squash Players, apart from when it specifically mentions 'Resident' or 'Non-Resident'.

Rules:

- 1) All Squash Courts can only be Hired via the On-Line Booking System (WebBookings), and all players must have a GoCardLess Account set up.
- 2) All 'Squash Sessions' are for ONE hour duration (**55** minutes playing time). (*Court 1 starts on the 'Hour', and Court 2 starts on the 'Half Hour'*).
- 3) You are only allowed to book **2 court sessions per day**, if you require more then a '**Multiple Hire Agreement Form**' is required to be completed. (*Any booking(s) you make are for your personal use only*).
- 4) All Squash Court Hires will be charged at the '**rates**' set for Residents or Non-Residents players, these '**rates**' are reviewed each year in October.
- 5) **Both** courts should only be used for Squash and Squash 57 (Racketball) with the appropriate footwear and equipment.
You must ensure all footwear (especially soles) are clean before entering the Squash Court(s) to avoid any damage to the floor or accidents whilst playing.
- 6) All On-Line Bookings must have the following:
 - Your Opponents Full Name.
 - Your Opponents Contact Details.
- 7) All children under the age of 16 must be accompanied by a responsible Adult. (*Age Restriction will apply to under 16 using the Leisure Centre*).
- 8) **Cancellation** of any booking must be at least 24 hours before your session begins, and the refund (less the transaction charge) will be paid back into your GoCardLess account.
Failure to do this and you will forfeit the money for the session.
- 9) **Residents** Squash Players must be registered on the On-Line Booking System as a 'Squash' player.
 - Your Key Fob must be used every time you enter the Centre.
 - You will be allowed to Hire Courts up to **7** days in advance. The Centre Manager reserves the right to change this period at any time. You will be notified via the Web Site or by Email of any changes.
 - You will pay the Resident Rate (**50%** discount) for court hire.
 - You can access the Centre to play squash, the Changing Rooms and Showers are now unavailable unless you have a 'swimming booking'.
 - Other restrictions may apply, please read the '**Squash Procedures**'.

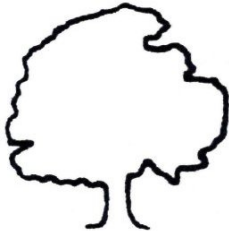

- 10) **Non-Residents** must complete a '**Registration Form**' to allow them access to the Leisure Centre and to use the On-Line Booking System.
The Manager of Herne Farm Limited will, once you have Registered and paid your Fees issue you with a Key Fob at a cost, so you can access to the Centre.
- This Key Fob must be used every time you enter the Centre.
 - You will be allowed to Hire Courts up to **5** days in advance. The Centre Manager reserves the right to change this period at any time. You will be notified via the Web Site or by email of any changes.
 - You will pay the Non-Resident Rate for court hire.
 - You are allowed via your Key Fob to access the Foyer, Squash Courts. Other restrictions may apply, please read the '**Squash Procedures**'.
 - You are also allowed to use the car park if a space is available at your own risk.
 - You must vacate the Centre once your Squash session has completed.
 - You are **NOT** allowed to use the Swimming Pool unless accompanying a Resident Squash player who has a 'swimming booking'. (*Age Restrictions - See Rule 13 below*).
 - The Swimming Pool is monitored by CCTV and any breach of the above rule will result in your access to the Centre being denied.
 - You are allowed to bring ONE named guest to play Squash with you.
 - You must ensure that they are aware of these Rules and comply with them at all times.
 - It is your responsibility to ensure this, and failure to do so could jeopardise your Registration.
- 11) As the Herne Farm Leisure Centre is owned by the Residents of Herne Farm you should be considerate of other users at all times.
- You will not cause unnecessary disruption to others.
 - You will also do your utmost to ensure others also observe the rules.
 - You are asked to keep noise levels to a minimum when not on court.
- 12) If you see any damage to the squash courts or other areas at the Centre you must report it to the Centre Manager during the next available office hours.
- 13) **You must have written permission from the Centre Manager and Board of Directors before the squash courts can be used for 'Coaching'**.
The 'Coaching' will only be permitted once the coach has provided copies of:
- A current England Squash Coaching Certificate.
 - A current DBS Certificate for coaching children at Herne Farm.
- Any other use of the courts is by special permission only.

- 14) Use of the **Swimming Pool** when accompanying a 'Resident Squash Player' is governed by the following rules:
 - Resident squash players are allowed ONE Non-Resident guest.
 - All children under 16 years old must be accompanied by a Resident Adult.
- 15) Your **Key Fob** can only be used by you:
 - It must be used every time you enter the Leisure Centre.
 - You are under a duty to report if it is lost or stolen.
 - You will pay the current replacement fee as set by the Board of Directors should it need to be replaced.
- 16) The **Non-Resident Registration** is at the discretion of the Centre Manager and the Board of Directors:
 - The **Registration** can be Terminated at any time.
 - Breach of any of the Squash or Centre Rules is likely to result in your access Key Fob being dialled out of the system.
 - Therefore you will no longer be able to access the Centre.
 - You will be unable to play squash at Herne Farm, even as a guest.
 - There are a maximum of **40 Registrations** available.
 - All **New Applications** will first be added to the '**Waiting List**', and once a place becomes available you will then be contacted on a first come, first serve basis.
- 17) The **Non-Resident Registration** will only be renewed:
 - Once payment has been made and received by Herne Farm Limited.
- 18) To **Cancel** your Registration you are responsible for:
 - Contact the Centre Manager to say you want to cancel the Registration.
 - Cancelling any Direct Debits you may have with Herne Farm Limited.
- 19) These rules are subject to change.
